[5] Thomas Guastella contends the indictment was fatally defective because it failed to inform him of the crime he was charged with and of the nature and elements of the alleged offense. The statute under which Thomas Guastella was prosecuted prohibits the "knowing or intentional and unlawful infliction of... physical injury on another person." Ind. Code § 35-42-2-1.5 (Burns Supp. 1989). We do not find it necessary to address Thomas Guastella's contention that the statute was defective because the statute does not differentiate between knowing and intentional infliction of physical injury. Nor do we have to determine whether "knowing or intentional" modifies "inflict" or "physical injury" separately.
