Giant cell arteritis (GCA) is one of the most common medium and large artery vasculitis in Western countries and it is often underdiagnosed because of its insidious onset and the lack of specific diagnostic tests. The diagnosis of GCA is based on the clinical manifestations and the 'trinity' of the American College of Rheumatology which consists of three observations: (1) polymyalgia rheumatica (two or more feverish episodes per week) plus the presence of one or more temporal artery tenderness; (2) headache and scalp tenderness; and (3) elevated erythrocyte sedimentation rate and/or C-reactive protein. GCA is difficult to diagnose when it presents as giant cell arteritis in a patient with rapidly progressive inflammatory polymyalgic manifestations. In this setting, an early diagnosis is helpful for the treatment, but there is no consensus on the diagnosis. We present the case of a patient with a rapidly progressive inflammatory polymyalgia characterized by fever, pain in the arms and legs, headache, skin tenderness, pancytopenia, and elevated inflammatory parameters. After application of the classical criteria of the 'trinity', the diagnosis of GCA was rejected due to normal temporal artery biopsy and negative rheumatoid factor. Afterwards, upon anamnesis, we documented the presence of back pain and bilateral conjunctivitis. The patient was finally diagnosed with giant cell arteritis by the anamnestic criteria 'Headache with jaw claudication plus new signs in the lower limbs', raising the suspicion of giant cell arteritis in a patient with a short disease course.
