## CLAAS ESIS (Parts Catalog)

All payments made to contractors or Type 2 claimants as a result of claims for damages arising from CLAAS agricultural machinery products will be reimbursed or replaced at CLAAS discretion, and upon deduction of all claims advanced by the contractors and Type 2 claimants as described in paragraph 3 of this form, minus and deduct, inter alia, contractors services and overhead incurred and fund expenses. The contractor or Type 2 claimant will receive payments from the escrow fund as provided for in the individual Claim Participation Agreement on account of any money advanced in consideration of claims for damages which is to be reimbursed or replaced. Any payment made by CFSIC to the contractor or Type 2 claimant will be made to the contractor only upon satisfactory proof that the funds were actually advanced on behalf of a claimant in payment for claims for damages arising from CLAAS agricultural machinery products. Prior to any payment being made by CFSIC to the contractor or Type 2 claimant it will be required to submit detailed proof of the advanced funds to the TPA for review to ensure the proof is satisfactory. Such proof shall include, but not be limited to, copies of all receipts and bank statements of any type of account, invoices and other records that substantiate that the funds were advanced on behalf of the contractor or Type 2 claimant. A contractor or Type 2 claimant shall not be eligible for payment by CFSIC without such satisfactory proof. The contractor or Type 2 claimant is deemed to have incurred costs and expenses not on account of CLAAS agricultural machinery products which will be deducted from any reimbursement and replacement payments by CFSIC.
