but I'm not convinced that is what the authors intended. The book does tend to provide more of an overview of the issues that arise in the business law context and less of an actual step-by-step model of the business law topics, which may have been what the authors intended. For example, in the introduction, the authors state that one of the goals of the book is to teach students how to think about the issues that arise in the business law context, but there is a total lack of any sort of instruction on how to think about the issues arising in business law, and one is left to guess as to what the authors believe the students should be thinking about. Moreover, the textbook includes virtually no reference to the business ethics literature, it also does not help with the students' understanding of the role of ethics in the business context. Overall, the book is too simplified to be useful in the business law context, and the authors appear to have placed too much emphasis on the business law topics and not enough emphasis on the ethical aspects. In fact, the authors may have actually chosen a course of action that would prevent a student from earning the course credit, as the textbook does not mention the possibility of failing the course. If this is the case, I would wonder why the course was even put together. It would be rather difficult to argue that this should be a required course for any business students, although the authors may have intended to create a business ethics textbook. If the book is to be used for that purpose, it would be better to devote a significant amount of space to addressing the role of business in the community, corporate law, accounting, financial statement analysis, and such, in order to help the students understand that the ethical issues arise in more than just the business law context. For example, students should learn that the ethical issues that arise in the business context are also applicable to non-business contexts, such as the criminal law.

i would also recommend that the authors provide more information on the role of business and what a business is. for example, in the introductory section, the authors state that business is defined by "the generation of a profit, which is defined as revenue exceeding expenses." this statement is somewhat misleading as many businesses do not generate a profit. an example of a business that generates a profit is a business that sells magazines and books, which generates a profit if revenue exceeds expenses. in fact, many businesses generate a loss. an example of a business that generates a loss is a restaurant, which generates a loss if expenses exceed revenue. i found the format of the book to be quite engaging and, therefore, i was able to get the most out of the class time i was allotted. for example, the first chapter starts out with a discussion of a fictional company in a fictional country (yugoslavia) and then moves into a discussion of corporate law in general. through this discussion, the authors provide a good introduction to general principles of business law. although i think that the discussions of conflict of law issues would have been more useful if they were presented in a way that would have allowed a more complete discussion of the choice of law analysis that would have been required to apply the principles of business law to the facts of the case. for example, the authors discuss the issue of choice of law in the context of an international merger and how the two sides chose a different set of laws that will govern the transaction. the authors do this without explaining the choices that were made and why the choice was made. 5ec8ef588b
